The details of kidney transplant are as under:

Package cost of Kidney transplant – USD 13500 approx.

Cost of evaluation approx 1000 usd

The above package will include the following:

Total Pre-workup of approx. USD 1800 will be part of the package

1. Kidney Transplant Cost
2. Surgeon's Fee (Only related to KTP)
3. Initial work up and investigations (related to KTP)
4. Stay of 8 days for the patient and 5 days for the donor in the hospital (for kidney transplant procedure)

5. Dialyses before the transplant – total no.8
6. Anti-rejection injections (max 2 in number)

The above package strictly covers only the Kidney Transplant Procedure and will not include the following:

1. Cost of HLA and cross Match
2. Stay beyond the above-mentioned period
3. Any other disease / complication
4. Investigations for any other complication/ disease
5. Professional charges of any other consultant not related to KTP
6. Any other additional procedure
7. Use of special drugs/ consumables if not part of KTP
8. Any other personal expense incurred by the patient/donor would not be covered under the package

Points to be kept in mind:

1. Donor should be related and must be one of the relative who has similar blood group or O+ve group.
2. The patient needs to be accompanied with a donor who should be of the same blood group and as per our country's organ transplantation guidelines, the donor has to be also a first degree relative (i.e., father, mother, brother, sister, spouse and children) of the recipient.
3. Please note that it takes around 2-3 weeks for the patient and the donor to get the final clearance from the government committee appointed by our Indian Government before the actual transplant surgery takes place.
4. Patient and donor must come on a Medical Visa for 2 months which could be extended if required
5. Patient and donor need to keep in mind that the initial work up and tests could take some time and would be done both on IPD and OPD basis depending on the requirement of the patient
6. Transplant will take place once all the tests and the condition of the patient is perfect. So, patient and donor have to be counselled not to PANIC
7. The final treatment plan is always confirmed after reviewing the medical records of the patient.
8. Apart from the hospital stay the patient is advised to stay for about a month in India after the procedure for recuperation and follow-up.

DOCUMENTS REQUIRED FOR ORGAN TRANSPLANT

Donor from the family –Parents, siblings, spouse, children who are above 18 years of age
Immediate relatives except spouse:

- Declaration certificate for the donor and the recipient from the country of Origin •
Family tree
- Birth Certificate / School certificate of Donor and Recipient
- National Identity proof of the Recipient, Donor and the immediate relative
- Copy of the passport
- Valid Medical Visa for Recipient & Donor
- Attendant Visa for the Immediate relative

Note:

- If Donor unmarried – One of the Parent / elder siblings' presence is essential.
- If Donor Married – Presence of Spouse is essential/ children above 18 years of age
- In the event of Parents not alive, Elder Brother / Sister / Son or Daughter to be physically present.
- Donor Close Relative must be physically present for Authorization Committee Clearance.

Spouse as donor:

- Declaration certificate for the donor and the recipient from the country of Origin
- Marriage Certificate
- Birth certificate of the kids
- Old family photographs
- National Identity proof of the Recipient, Donor and the immediate relative
- Copy of the passport
- Valid Medical Visa for Recipient & Donor • Attendant Visa for the Immediate relative Note:
- Immediate relative to be accompanied parent or any of the siblings of the donor or child above 18 years.
- Donor's Close Relative must be physically present for Authorization Committee Clearance.

The ID proofs and the other documents shall be translated by the official translator to English from the native language

The original documents shall be produced before the Authorisation committee. **Therefore, carry all the original documents.**

In view of the above supporting documents the below mentioned Documents required to be prepared in India for the Clearance from

Authorization Committee (Once the donor is certified as a healthy donor)

- Affidavits from Recipient, Donor and the immediate relative of the donor which should be attested by the Notary Public
- Legal Forms
- Donor & Recipient Performas
- 20 passport size photographs of Recipient and Donor each
- 5 Passport size photos of Immediate relative
- NOC from the Embassy which is in India
- (DNA Test is mandatory to establish relationship between Donor & Recipient & Donor Close Relative)
