- 1. I acknowledge that the IELTS (or equivalent) requirement for the course for which I have applied is IELTS 6.5 and that the language of instruction and written and spoken administration, communication and assessment at the Film Scoring Academy of Europe, and the programme to which I have been admitted, is English. The Film Scoring Academy of Europe has satisfied itself in the admissions application process that I have the requisite standard of English to participate successfully in the programme; I acknowledge that it is my responsibility to maintain my level of English at the this standard for the duration of the programme.
- 2. Medical insurance is a mandatory requirement for all students; all students must provide evidence of satisfactory medical insurance in Bulgaria for the duration of their stay.
- 3. I have not broken the terms and conditions of any Bulgarian visa or residency permit.
- 4. I understand that the programme to which I have been admitted is a full time programme; leave for work, recording or other artistic or professional commitments may only be granted on foot of specific and written permission by the Programme Director.
- 5. I understand that any scholarship award I may receive cannot be combined with another alumnus or early enrolment discount. In the event that more than one of these is applicable, the higher award/discount will supersede the other(s).
- 6. I understand that I may only proceed in my classes providing the tuition fees payment schedule is fully up to date, and that I may be subject to withdrawal from classes if I become delinquent on payments.
- 7. I acknowledge that full attendance is a requirement of the programme, and that the institution is not responsible for reduced performance levels, grades, missed recording sessions or other pedagogical opportunities if I am absent from relevant classes without an appropriate and excused explanation, or because I have been withdrawn from class because my tuition fees payment schedule is not up to date.
- 8. I understand that I must arrive in time and on the dates specified for registration and orientation for all semesters and not leave without an excused reason until each semester is completed.
- I accept that the Film Scoring Academy of Europe, Irish American University, reserves the right to cancel my application
 or formally withdraw any documents issued from Irish American University or its constituent colleges if any of the above
 statements are found to be untrue.
- 10. Refund Policy. Students who have paid their fees but are subsequently unsuccessful in their visa application will be refunded <u>all</u> the fees they have paid in a timeframe that does not exceed 20 working days. In the event of this occurring: all refunds are subject to a €300.00 non-refundable visa administration fee. The student must provide documentary evidence of visa refusal. Unless a visa is refused, the following refund policy applies:
 - o The Tuition Deposit is non-refundable under any other circumstance.
 - All other Tuition Fees are 50% refundable prior to 15 September, 2025
 - o All other Tuition Fees are non-refundable as of 15 September, 2025
